The undersigned, subscriber to these Articles of Incorporation, each a natural person competent to contract, hereby associate ourselves to form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation is FLAGSHIP ENTERPRISES, INC.

### ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of purchase, development and sales of real property and any other lawful business, including, but not limited to:
