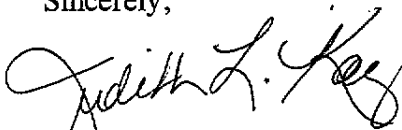

The undersigned, being the President and Secretary of Mid-Florida Radiation Oncology, P.A., Florida corporation, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted unanimously by all of the Directors and all of the Shareholders at a meeting duly held by them on the 29 day of February, 2000:

AMENDMENT

Article V is amended to read as follows:

This corporation is authorized to issue two thousand(2,000) shares of Fifty Cent (\$.50) par value common stock which shall be fully paid and nonassessable. The stock of this corporation shall be issued, assigned and/or transferred in strict accordance with such bylaws as the corporation shall from time to time make with a lien reserved in favor of the corporation upon all of its capital stock for any indebtedness which may at any time be due by the holder of the same unto the corporation.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

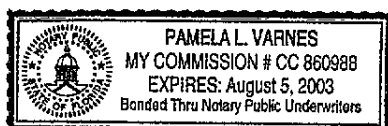

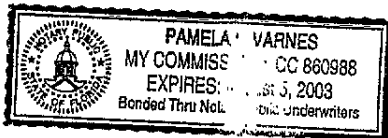

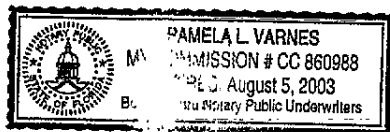
