ARTICLES OF INCORPORATION OF MID-FLORIDA RADIATION ONCOLOGY, P.A.

AMENDMENT

Article V is amended to read as follows:

ARTICLE V. CAPITAL STOCK

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
