**ARTICLES OF INCORPORATION**

**OF**

**CHRISTINE'S WATERSIDE, INCORPORATED**

The undersigned, for the purpose of forming a corporation under the Florida of General Corporation Act, do hereby adopt the following Articles of Incorporation:

**Articles 1. Name.** The name of the Corporation is: **Christine's Waterside, Incorporated.**

**Article 2. Duration.** The duration of the Corporation is perpetual.

**Article 3. Purpose.** The general purposes for which the Corporation is organized are the following:

**A. To engage in and transact any lawful business for which corporation may be incorporation under the Florida General Corporation Act. No other purpose limited this general purpose in any way.**

**B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.**

**C. To engage in Resturant/Bar Business**

**Article 4. Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is 5,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**Article 5. Initial Registered Office and Agent.** The street address of the initial Registered office of the Corporation is 1110 Pinellas Bayway Suite 206, Tierra Verde, Florida and the name of its initial Registered Agent at that address is Christine Sparacio. The principle office is the same as the registered office.

**Article 6. Initial Board of Directors.** The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one.
