## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTHERN TV CORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, SOUTH CORPORATION adopts this Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is SOUTHERN TV CORPORATION.
