

The undersigned, acting as incorporator of a corporation under the Florida Business Act, adopts the following Articles of Incorporation for such corporation:

### Article I Name Of Corporation

The name of the corporation is TEMPTATION INVESTMENT TRUST, Incorporated.

### Article II Principal Office / Mail Address

### Article III Capital INVESTMENT Stock

The number of shares the corporation is authorized to issue is 1000 shares. The stock shall be one class.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty(30) days of the receipt of the notice from the corporation.
