The undersigned natural person, of legal age, competent to contract as an Attorney at Law, licensed or otherwise legally authorized to practice by and within the State of Florida, hereby acting as Incorporator for the purpose of forming a Professional Service Corporation for profit by virtue of the provisions of Chapter 621, Florida Statutes, and Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

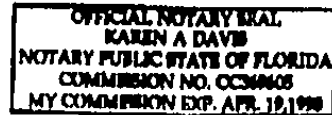
