THE UNDERSIGNED, acting as the Incorporator of a corporation under the "Florida General Corporation Act," adopts the following Articles of Incorporation for such Corporation.

CORPORATE NAME BARBIERI ENTERPRISES

NATURE OF CORPORATE BUSINESS

This Corporation is organized for the purpose of transacting any of all awful business permitted under the laws of the United States and of the State of Florida.

ARTICLE III CAPITAL STRUCTURE
