The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Tarticles of Incorporation for such corporation:

- 1. Name of Corporation. The name of this corporation shall be KOONDOG CHARTERS, INC.
- 2. <u>Principal Office of Corporation</u>. The address of the principal office of the corporation shall be 12554 Capri Circle North, Treasure Island, Florida 33706.
 - 3. Duration. The period of its duration is perpetual.
- 4. <u>Purposes</u>. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
