

THE UNDERSIGNED HERLBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE

THE NAME OF THIS CORPORATION SHALL BE:

ARTICLEI

THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF UNITED STATES AND OF THE STATE OF FLORIDA.
