The undersigned, for the purpose of forming a corporation under Chapter 621 F.S., the Professional Association Act, hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is STEVEN ROBERT SMITH, P.A.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation is formed to transact insurance services and all lawful business for which corporations may be incorporated under Chapter 621 F.S., the Professional Association Act.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 7,500, all of which shall be common shares with a par value of \$1.00

ARTICLE V
