ARTICLES OF INCORPORATION OF NATURE'S POWER, INC.



The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to these Articles of Incorporation.

3-21-95 ARTICLE 1- NAME

The name of this corporation is NATURE'S POWER, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence. The corporate existence commences as of March 21, 1996.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- a) To engage in buying, selling, transferring, assigning, discounting, loaning or borrowing money upon and pledging as collateral, and otherwise dealing as principal agent or broker.
