ARTICLE I

The name of this Corporation is: Asia-America
Import/Export, Inc.

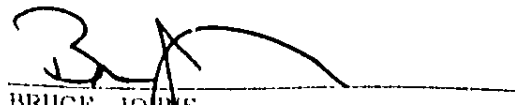

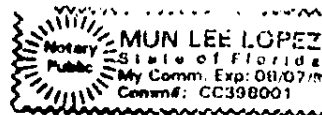
