ARTICLES OF INCORPORATION  
OF

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

Name

The name of this Corporation is FANTASY GOURMET COFFEE, INC.

ARTICLE II

Duration

This Corporation shall have perpetual existence.

ARTICLE III

Principal Place of Business and Mailing Address

109 S.E. 1ST AVENUE, HALANDALE, FLORIDA 33009

ARTICLE IV

Purpose

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and the State of Florida, and to any and all of the things hereinafter mentioned as fully and to the same extent, as natural persons might or could do, to-wit:

(a) To carry on the business of selling and distributing all types of coffees and teas, coffee machines and all other merchandise pertaining to the preparation of coffee and tea.

(b) To cater affairs where coffee and tea are served.

ARTICLE V

Capital Stock

The Corporation is authorized to issue One Thousand (1,000) shares, all of one class, at One Dollar (\$1.00) par value.

ARTICLE VI

Initial Board of Directors

This Corporation shall one (1) Director initially. The number of Directors may be either increased or decreased from time to time, by an Amendment of the By-Laws of the Corporation, in the manner provided by law.

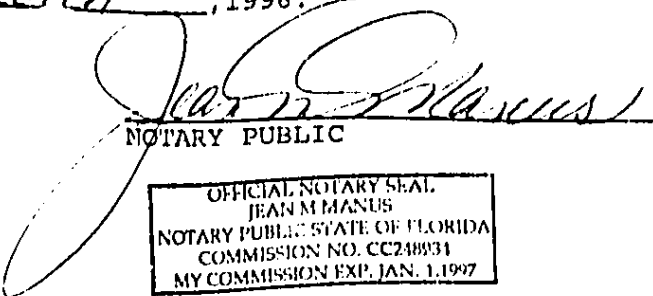
