#### ARTICLE I - NAME:

SECROPORTS OF STATE

The name of this Professional Service Corporation is:
THOMAS E. MYER, Psy.D., P.A., hereinafter referred to as the "Corporation")

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:
