

ARTICLE I  
Corporate Name and Address

The name of the corporation is Suncoast Masonry of Broward, Inc. located at 3861 NW 102nd Ave Coral Springs, Fl 33065.

Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these articles of incorporation with the Department of State of the State of Florida.


