The name of this corporation shall be Jose A. Rochet, P.A.

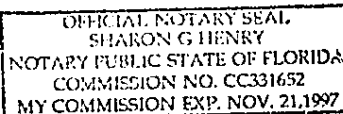


