Articles of Incorporation for FEATHERS of Orlando, Inc.

ARTICLE I. CORPORATE NAME

The name of this corporation in: FEATHERS of Orlando, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of management services and other related activities, and other contractual related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having par value of at least \$1.00 per share.
