ARTICLE I

The name of the corporation is: JON S. KLINE, INC.

INDEMNIFICATION



The Corporation elects to have pre-emptive rights, pursuant to the provisions of Florida Statute 607.0630 (1995).

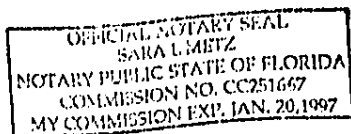
