ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is SPIKE ELECTRIC, INC.

ARTICLE TWO

The general purpose for which the corporation is organized is to transact any or all lawful business for which corporations may be incorporated under the Florida General Corporations Act; and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing; including but not limited to marketing the products or services.

ARTICLE THREE

The aggregate number of shares which the corporation is authorized to issue is FIVE THOUSAND (5000) shares of common stock with par value of ONE DOLLAR (\$1.00) per share

ARTICLE FOUR

The duration of the corporation is perpetual.

ARTICLE FIVE

The street address and mailing address of the initial registered office of the corporation is 3389 Sheridan Street, Suite 128, Hollywood, FL 33021 and the name of its registered agent is Joel P. Hamilton. The principal place of business is the same as the registered office.

ARTICLE SIX

The corporation shall have not less than one (1) nor more than five (5) directors. The number shall be fixed by the By-Laws and may be changed from time to time, within the prescribed limits.

ARTICLE NINE

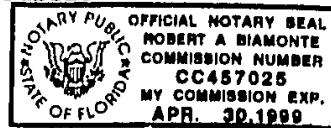
