ARTICLES OF INCORPORATION

OF

SNEEKER'S SECURITY CONSULTANTS, INC...

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is SNEEKER'S SECURITY CONSULTANTS, INC..

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in the operation of a security training service for business and individuals within and without the State of Florida and any other business activity authorized under the laws of the State of Florida or of the laws of the United States.

ARTICLE IV

The Corporation shall have authority to issue one (1) class of Capital Stock which shall consist of five thousand (5,000) shares of one dollar (\$1.00) PAR value Common Stock.

ARTICLE V

The corporation shall commence business upon filing with the Secretary of State of the State of Florida.

ARTICLE VI

The principal place of business shall be located in Lee County, Florida. The address of the principal place of business shall be 1106 Lucerne Ave., Cape Coral, Florida. The corporation shall have the right and authority to transact business at such other place or places within or without the State of Florida as the corporation may be resolution designate.
