

## ARTICLES OF INCORPORATION

OF

We, the undersigned, HARRIET PRESCOTT and GEROY NEAL, JR. do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.
