The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

PAVEMENT PAINTERS, INC.


The number of directors shall be either increased or diminished from time to time by the By-Laws, but shall never be fewer than one (1).
