The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Corporation is: SPRINGS PALM, INC. and its address is: 11888 Royal palm Boulevard, Coral Springs, Florida 33065.

Article 2. Duration. The duration of the Corporation is perpetual.

<u>Article 3. Purposa.</u> The general purposes for which the Corporation is organized are the following:
