SECTION 9.01 *To engage in every aspect and phase of the business of Any and all business which is not contrary to the laws of the United States of America and of the State of Florida.*

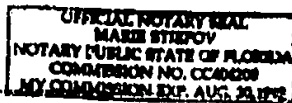
