Please be advised that this office represents The Belmont Steaks, Inc. in connection with their corporate status with the Secretary of State for the State of Florida. Please be advised that The Belmont Steaks was formerly known as Investors' Opportunities, Inc. This office had previously incorporate Investors' Opportunities, Inc. for one of my clients. That particular client decided not to move forward with this particular enterprise and I was approached by Shirley Fuentes, unrelated to my original client, for the purpose of incorporating her business The Belmont Steaks, Inc. I decided to use Investors' Opportunities, Inc. and did a name change for her by means of an Amendment to Articles of Incorporation which was filed with your office on April 11, 1997, a copy of which is attached hereto. the Articles of Incorporation, the business address was listed as 405 South Howard Avenue, Tampa, Florida 33606.

Apparently, there has been some confusion in the Department's records for this company. Last year, we did not receive the corporate annual report and wrote the departmet accordingly. Enclosed is a copy of my letter of August 6, 1997.

Notwithstanding this letter, we still did not receive the corporate annual report form for 1998 inasmuch as it was apparently still forwarded to my old client's address at 9205 Connechusett Road, Tampa, Florida 33617. She was unaware of the problem until recently when it occurred to her that there had been no filing for 1998. (She was under the impression that the necessary filings for 1997 had occurred at the time of doing the Amendment to the Articles.) As a consequence, the department records reflect that the annual report for 1997 and 1998 were not filed timely and she is now facing substantial penalties in order to have the corporation reinstated.
