ARTICLE I-NAME

The name of this Corporation is SILVIA'S CLEANING SERVICE, INC. The mailing address is 6278 N. Federal Highway, #552, Ft. Lauderdale, FL 33308.

ARTICLE II-DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence upon filing.

ARTICLE III-PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV-CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

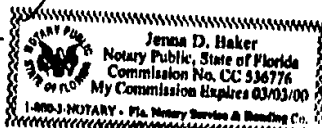
