ARTICLES OF INCORPORATION

ARTICLE I - NAME

MELANASSEE, FLORIDA

The name of this corporation is C & M Custom Contracting, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
