OF

ARTICLE I - NAME

The name of this Corporation is: HOMB & ESTACO INVESTMENTS, INC.

ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.

When payment of the consideration for which shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and non-assessable.

ARTICLE V - PREEMPTIVE RIGHTS

This right shall be exercised by the said shareholders in a period of sixty days from the resolution taken by the Board of Directors or Shareholders Meeting, or from the notice to sell delivered by the selling shareholder to the Secretary of the Corporation.

 negligence or willful misconduct in the performance of his
 duties. The rights accruing to any person under the foregoing
 provisions shall not exclude any other right to which he may
 lawfully be entitled, nor shall anything herein contained
 restrict the right of the Corporation to indemnify or re-
 imburse such person in any proper case even though not
 specifically herein provided.

ARTICLE XI - REMOVAL OF DIRECTORS

Any Director, or the entire Board of Directors may be removed
 with or without cause, by a vote of the holders of a majority

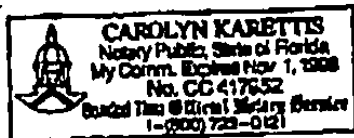
