

### ARTICLES OF INCORPORATION



### ARTICLE I - NAME

The name of this corporation is Kiefer Supply Corp.

### ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
