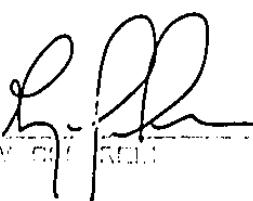

ARTICLE V

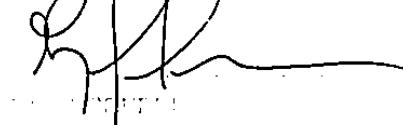
The Corporation will not commence business until it has received full payment of the share consideration of the value of \$1,000.00.

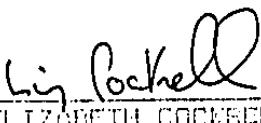

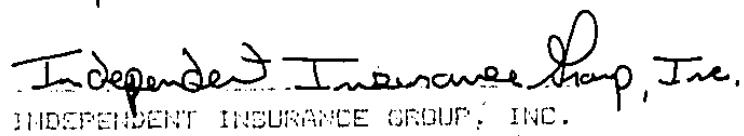
