ARTICLES OF INCORPORATION

OF

RICK'S MOBILE MARINE SERVICE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is RICK'S MOBILE MARINE SERVICE, INC.
