OF

ARTICLE I - Name

The name of this corporation is:

ARTICLE X - Effective Date


These Article of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

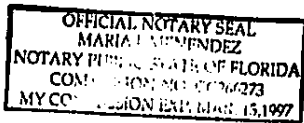
