ARTICLE I - Name

The name of this corporation is:


These Article of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

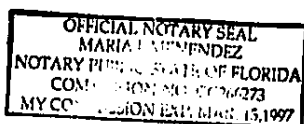
