ARTICLES OF INCORPORATION ARTICLE ONE

NAME

The name of this corporation is: TELEARTE INTERNATIONAL NETWORK THE

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted --- under the laws of the United States of America an the laws of the ---- State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on - which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

ARTICLE SEVEN

BY LAWS
