I, the undersigned, a natural person competent to contract to hereby make, subscribe and file thses ARTICLES OF INCORPORATION for the purpose of organizing a corporation under the laws of the State of Florida.



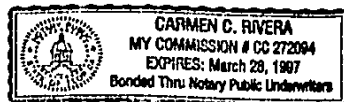


