The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida:

ARTICLE I. NAME

The name of the Corporation shall be:

ORLANDO LANDWORKS, INC.

The principal place of business of this Corporation shall be 12612 Kirby Smith Road, Orlando, Florida 32832.

ARTICLE II. DURATION

This Corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

1. This Corporation is organized to conduct business in the State of Florida;

All Corporate powers shall be exercised by or under the authority of, and the business and affairs of this Corporation shall be managed under the direction of the Shareholders of this Corporation.




