The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form this Corporation under the laws of the State of Florida.

ARTICLE I. NAME AND LOCATION

The name of this corporation for profit shall be: R.H. Davis Investment, Inc., at: Highway 121 North, Macclenny, Florida 32063 whose mailing address is: P.O. Box 1701, Macclenny, Florida 32063.

ARTICLE II. DURATION

This corporation shall have perpetual existence and shall commence to exist as of the filing date of these Articles of Incorporation.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business which may be proper within the United States of America.

ARTICLE IV. CAPITAL STOCK



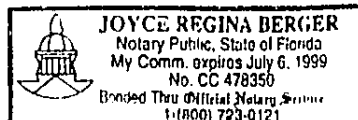
