**ARTICLES OF INCORPORATION
OF
URGENT CARE MEDICAL CENTER OF JUPITER, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles Of Incorporation.

ARTICLE I - NAME OF CORPORATION

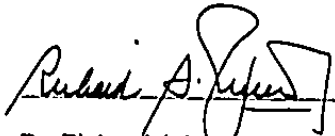

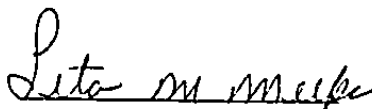
