# ARTICLES OF INCORPORATION

OF

SEAGER, INC.

ARTICLE I

PART TO AH 10: 02

The name of this corporation is Seager, Inc., whose principal address is 24 Matador Lane, Davie, Florida 33324.

#### ARTICLE II

The general nature of the business to be transacted by this corporation is to engage as private invesigator, a business permitted under the laws of the State of Florida.

#### ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.
