ARTICLES OF INCORPORATION
OF

STRUCTURAL CONCRETE OF ORLANDO, INC.

The undersigned, acting as sole incorporator, and desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION AND CORPORATE ADDRESS

The name of the corporation shall be STRUCTURAL CONCRETE OF ORLANDO, INC., having a principal address at: 353 Terrace Drive, Oviedo, FL 32765.

ARTICLE II - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III - GENERAL PURPOSES

The general purposes for which the corporation is organized shall be:

(1) To own, operate and manage a construction business; to act as a general partner in any entity engaged in any of the foregoing; or for any and all other business venture or ventures related to any of the foregoing.

(2) In addition, it is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida General Corporation Act, as the same may be from time to time amended; provided, however, that notwithstanding the generality of the foregoing, the corporation is not hereby authorized to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair, or exposition business.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that the corporation is authorized to issue and have outstanding is 1,000.00 shares, which shall be designated as Common Shares, having no designated par value.

**ARTICLE V - INITIAL REGISTERED OFFICE
AND REGISTERED AGENT**

The initial registered agent of the corporation in the State of Florida and address of the same is: Steven E. Stines, 353 Terrace Drive, Oviedo, FL 32765.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

A. The initial number of directors of the corporation shall be two.

B. The number of directors of the corporation may be increased or decreased from time to time pursuant to By-Laws adopted by the shareholders, but shall never be less than the minimum number of directors required by applicable law.

ARTICLE XI - PRE-EMPTIVE RIGHTS

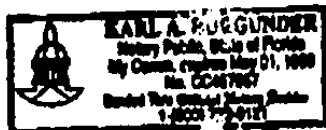

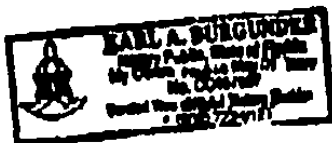
