ARTICLE | - NAME

The name of the Corporation is SHIRLEY MARTIN MYERS L.C.S.W., P.A.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE | | | - NATURE OF BUSINESS (Special Purpose)

The special purpose for which this corporation is being organized shall include the practice of Licensed Clinical Social Worker services as a professional medical corporation and to carry on services incident thereto, the practice of clinical social work is the sole and exclusive professional medical service to be rendered by this corporation. D. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire and dispose of the shares of the capital stock or any bonds, securities, or other evidence of indebtedness, created by any other corporation of the State of Florida or any other State or government and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

E. The foregoing enumeration of purposes shall not be deemed to limit or restrict the general powers of the corporation conferred on it by law, or to limit or restrict such powers as may be implied to it for the proper exercise of its express purposes and

the performances of its authorized functions.

ARTICLE IV - SHARES
