Pursuant to the provisions of Florida Statute Section 607.1006, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Curran Financial Consulting, Inc.
2. Article I of the Articles of Incorporation of Curran Financial Consulting, Inc. is hereby amended in its entirety to read as follows:

**ARTICLE I**

**Name**

The name of the corporation is Smooth Operations, Inc.

3. Article III of the Articles of Incorporation of Curran Financial Consulting, Inc. is hereby amended in its entirety to read as follows:

**ARTICLE III**

**Purpose and General Powers**

The specific purpose of this Corporation shall be the transaction of any and all lawful business related to the operation of a Tropical Smoothie franchise. This Corporation shall have all of the powers enumerated in the Act and all such other powers as are not specifically prohibited to corporations for profit under the laws of the State of Florida.
