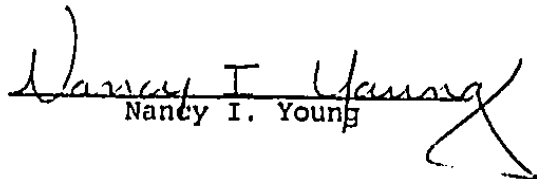

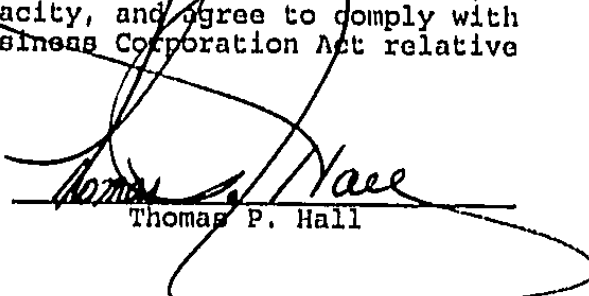

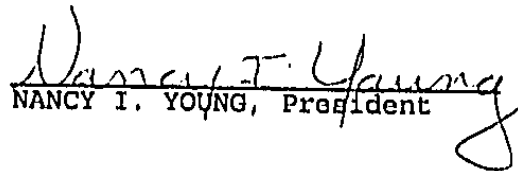
1. The name of this corporation is currently Insight of Port Charlotte, Inc.

INSIGHT OF FLORIDA, INC.

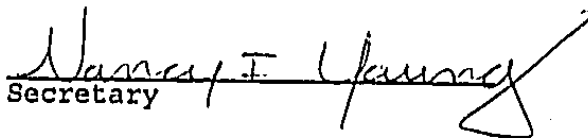

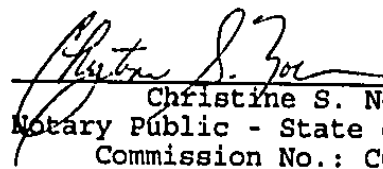
