**ARTICLE I - NAME AND MAILING ADDRESS**

The name of this corporation is SKYWAY VIDEO, INC. and the mailing address of this corporation is 1641 Commerce Avenue, North, St. Petersburg, Florida 33716.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**


