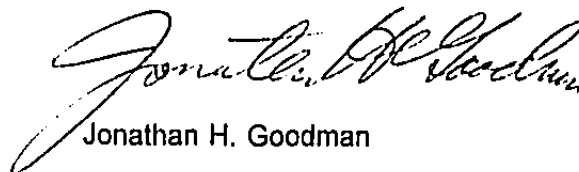

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is 12th Street Pub, Inc..

ARTICLE II.

The main location where the company shall conduct its business is 2124 Huron Street, Jacksonville, Florida 32205.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purpose of the corporation shall be to sell food and beverages to the general public and for any and other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares of common stock with a par value of Five Dollars (\$5.00) per share.

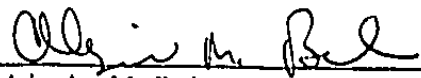

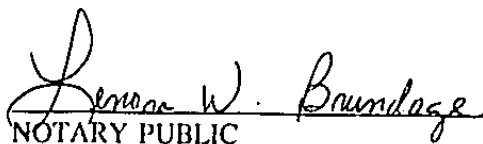
