ARTICLES OF INCORPORATION
OF
SINEE CORP.

The undersigned subscriber to these Articles of Incorporation, being a natural person hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is: SINEE CORP.

ARTICLE II

NATURE OF BUSINESS

The nature of business to be transacted by this corporation is real estate holdings, rental and investment, together with any and all lawful business pursuant to the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 7,500 shares of common stock, which shall have a par value of \$1.00 per share.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is not less than \$500.00.

This corporation shall have perpetual existence.

ARTICLE VI

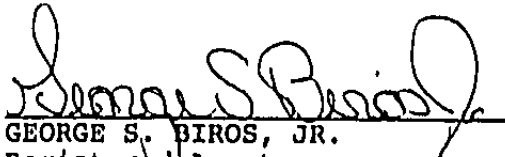

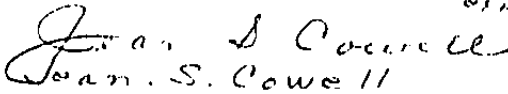
