The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: CAYMAN SHUTTERS, INC.

The duration of the corporation is perpetual.

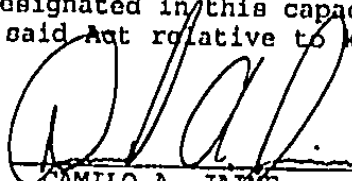
