ARTICLE 1 - Name

The name of the corporation is DON HURT & ASSOCIATES, INC..

ARTICLE 2 - Address

The street address of the initial principal office of the corporation is 4551 Whimbrel Place, Winter Park, FL 32792. The mailing address of the corporation is P.O. Box 5550, Winter Park, FL 32793.

ARTICLE 3 - Shares

This corporation is authorized to issue 100 shares of \$1.00 par value common shares. All issued shares must be represented by certificates.

ARTICLE 4 - Preemptive Rights

Each shareholder, upon the sale for money of any new shares of this corporation of the same class or series as that which the shareholder already holds, shall have the right to purchase a pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 5 - Initial Registered Office and Agent

The street address of the corporation's initial registered office is 4551 Whimbrel Place, Winter Park, FL 32792 and the name of the initial registered agent at that office is Donald W. Hurt. The written acceptance by the registered agent is attached.

ARTICLE 6 - Incorporator

ARTICLE 7 - Initial Board of Directors
