**ARTICLES OF INCORPORATION  
OF  
TREASURE COAST EXECUTIVE LAWN SERVICE, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be 'TREASURE COAST EXECUTIVE LAWN SERVICE, INC. and its principal business and mailing address is 1433 SW San Estaban, Port St. Lucie, Florida 34953.

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV**

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of \$.01 par value common stock.

**ARTICLE V**

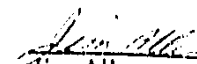

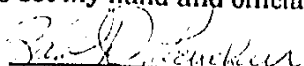

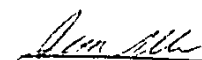
